S. Broward Drainage District – Requiring Engineer to Inspect Drains – Skip called and left messages. We need to make sure storm drains are clear to the lake (2 on Bristol, 2 on Brighton, 2 on Newcastle, 2 on Castlegate. – only when pool is drained or we have a lot of rain. – Supervisor finally called back gave engineers contact info Skip to reach out.

Security Cameras for Pool – Moises to give a schematic to provide power at top of poles camera's have a 110 charger pwer plug. FPL Can drop a box in pool area. Need 100 amps. – Patrick can set up - Larry Elliott from the Police Department provided his contact information 954-553-1151, he also let us know that having fake cameras at the pool is a liability issue.

Broward Dept of Health – Assessment of Public Pool to be Completed – Pool guy to fill out form "Florida Health Dept Pool Opening Assessment' – we were told we cannot open the pool without an attendant to wipe down chairs/tables etc. - Pool will need to be resurfaced in January.
